It is respectfully submitted that the respondents Nos. 1 to 10 managed to foist false/fabricated case of thief of buffaloes on me, my brother Gulzar Ali & others through one Forman Ali Bhatti, who is not only himself hardened criminal and son of notorious hardened criminal Sultan Bhatto who is passing sentence of 3 years R.I for narcotics activities in central prison sukkur. On the other hand, I and my brother Gulzar Ali are respectable, peace loving and law abiding citizen. Zamindar owning Banana Garden on vast area of my lands and running business by holding Agencies of various products. It is unbelievable that a man of my status should steal buffaloes. Also I was Forman Nazim Union Council Jam Noorullah, Taluka Kandirao, District Naushahro Feroze.

That the respondents No. 1 to 10 in odd hours of night broke into my house which is situated opposite to police Station Kandirao, maltreated and theorized respectable Pardanasheen ladies and Children, so much so that old mother suffered heart attack and went unconscious. The respondents thereafter looted my valuables viz gold ornaments / jewelry, cash Rs.85,000/-, 3 TV sets, 2 Electric Motors etc and my buffaloes, goats etc and arrested my brother Gulzar Ali Sahito and took him on police Mobile to PS Halani, where he was put to sheer third degree physical and mental tortures. The respondents No.4 and 5 by issuing threats of killing him in custody extorted Rs.2,30,000/- from my brother Mir.Khan Sahito.

That my brother Gulzar Ali Sahito in account of constant physical and mental tortures collapsed in serious near dying condition. He was hospitalized at R.H.C Mehrabpur District naushahro feroze. In view of his serious condition he was referred to People Medical College Hospital Nawabshah, wherefrom he was referred to National Institute of Cardio Vascular disease Karachi.

That Honorable Additional session Judge Kandirao has please to grant him bail and released him on bail.
