ORDER

Malik Abdul Aziz Khan appeared alongwith Addl. AG and submitted report. A perusal where of indicates that in pursuance of murder of Azizullah Khan S/o Hafiz Allah Dad vide FIR No.107/92 dated 15th June 1992 under Section 302/148 and 149 PPC. Khan Zaman Khan father of Islam Bibi alongwith others were challaned and were awarded life imprisonment vide judgment dated 14th February 1994 passed by the Sessions Judge Mianwali. Later on, in the year of 1997 the respectables/arbitrators of the area namely Allah Dad s/o Sher Gul Khan, Ghulam Abbas, Khalid Khan and Mumraiz Khan got effected a compromise between the parties in pursuance whereof two hands of girls namely Arshad Bibi, (17 years) and Islam Bibi (9 years) of the accused party were given to the deceased party. Marriage of Arshad Bibi was performed with Allah Nawaz brother of deceased Aziz Ullah who had already four children, while Shari Nikah of minor Islam Bibi was performed with minor Taj Rasool another brother of the deceased. Now Islam Bibi do not want to go with Taj Rasool in lieu of Wanni, therefore, on her hue and cry a case was registered by her vide FIR No.19/06 dated 6th March 2006 under Section 310-A/109 PPC at PS Paikhel decision of which is pending on the file of Rana Qamar Ali, Civil Judge/Magistrate Mianwali. It is alleged by Islam Bibi that despite the fact that case had been 2. registered but arrangements were being made for her forcible sending out



(Rukhsti) with Taj Rasool, therefore, she got published a news item requesting this Court for her protection.

- 3. Malik Abdul Aziz Khan, DPO Mianwali undertook that he will provide protection to Islam Bibi, probe into the matter and will settle the matter between the parties outside the Court.
- 4. He may do so. However, I direct the Trial Court to dispose of the matter expeditiously within a period of two months without fail, by conducting day to day proceedings and send a copy of the judgment to this Court for perusal in Chamber.
