**ORDER**

Learned Additional Advocate General stated that two persons namely Wajid and Tariq who are *prima-facie* responsible for causing murder of Shehzad Kiani husband of Mst. Hanna Yasmin have been apprehended while the third accused Ishtiaq is still at large. Efforts are being made to cause his arrest and investigation is going on. He stated that evidence has been collected and DPO Jehlum has assured that arrest of the accused will be caused. He is directed to take all necessary steps and submit report to Registrar for our perusal. In the meantime after completion of investigation Challan will be submitted and the trial Court will proceed with the case independently without being influenced in any manner from the present proceedings.

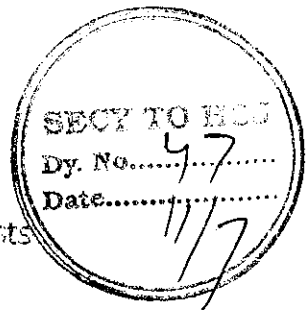

Honourable sir:

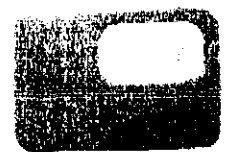
