ORDER

Learned Additional Advocate General appeared alongwith S.P. (Potohar) and produced Mst. Asia who was earlier married to one Muhammad Hussain, who according to her statement, divorced her. During the subsistence of her marriage, she was sold by Muhammad Hussain and now she has contracted marriage with Shamshir Ali. She is not much aware about the deal of the sale ^{- between -} by Muhammad Hussain ^{- and -} ~~between~~ Dilawar Hussain etc. Present husband of the lady Shamshir Ali is also present and he stated that she is his wife and is in the family way. Mst. Tajbro mother of Mst. Asia is also present and stated that she is happy that her daughter has been traced and she has contracted marriage.

2. In pursuance of a report published in the daily Jang, directions were issued to police for effecting the recovery of the abductee i.e. Mst. Asia. As now she has been recovered and police has been registered case against the culprits and in view of statement so made by Mst. Asia she is happily living with her husband Shamshir Ali, therefore, as far as this Court is concerned, no further action is required. However, police is directed to interrogate the case according to law so

the culprits/accused persons involved in the abduction etc. are brought to books. Police is also directed not to harass Mst. Asia as well as her husband Shamshir Ali. She is allowed to go with her husband and the police officer, who has produced Mst. Asia and her husband, is directed to take her back to Taunsa Sharif in safe custody. Petition stands disposed of.

ORDER

Learned Additional Advocate General appeared alongwith S.P. (City) and stated that Mst. Asia Bibi daughter of applicant Mst. Tajbro has been recovered from Taunsa Sharif and she made a statement before the Magistrate in Rawalpindi to the effect that she has contracted marriage with Shamshir Ali as her first husband Muhammad Hussain had divorced her and presently she is happily living in the house of her husband but we are not satisfied from the manner her statement has been recorded because according to her mother Mst. Tajbro, she had no opportunity to had a conversation with Asia Bibi because in Taxila Police Station, so many people had gathered and subsequently, she had taken back to Taunsa Sharif. Let the police authorities produce Mst. Asia before the Court on 20.11.2009.

ORDER

Learned Additional Advocate General has placed on record report submitted by P.P.O. Punjab perusal whereof indicates that a case vide FIR No.466 dated 11.10.2009 under section 364, PPC at P.S. Taxila has been registered on the complaint of Mst. Tajbro and a special team has been constituted for the recovery of abductee and to arrest the accused in the case. Mr. Kamran Adil S.P. (Pothohar Town) is also present. He has stated that accused Muhammad Hussain and his father Habib ur Rehman both have been arrested from Karachi; that arrangements are being made for shifting them to Rawalpindi and the police are confident that Mst. Asia would be produced before this Court in the near future. Case is adjourned to 18.11.2009. However, if in the meanwhile, Mst. Asia is recovered, she shall be produced before the Sessions Judge, Rawalpindi for recording her statement.

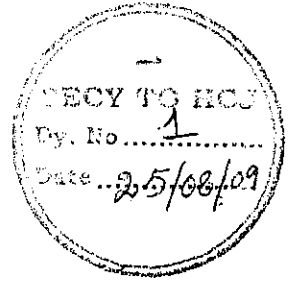

لاہور: بیوی بچے کا اقرار کر لیا بعد ازاں 15 روز میں آئے والدین کے پاس لاپتہ لڑکی

بیوی کے زندہ یا مردہ ہونے کا کچھ پتہ نہیں چل رہا چیف جسٹس انصاف فراہم کریں خاتون راولپنڈی (گماندہ جنگ) مردان کے علاقہ مظہر گنہار ٹیکسلا میں رہائش اختیار کر رہی ہے کے ساتھ ہوتی تھی۔ سے ایک سال قبل بیانی جانے والی 18 سالہ آسیہ شادی کے بعد تاحال لاپتہ ہے۔ پولیس پانچ فرسٹ کر دینے کی متقاضی اطلاعات نے آسیہ کی برہنہ ماں بیوہ تاج بروگہ ایم پائل کر دیا۔ تاج بروگہ کے مطابق گزشتہ سال اگست میں آسیہ کی شادی محمد حسین ولد صاحب الرحمن جو مردان کا رہائشی ہے مگر کام کاج کی غرض سے ایک مہر سے اس نے

الرحمن کی بلا گیا۔ اس موقع پر پولیس کے ذریعہ محمد حسین نے اقرار کیا کہ اس نے منڈی بہاؤ الدین میں رہائش پذیر اپنی بہن نسرتین اور اس کے خاندان لیاقت کی مدد سے اپنی بیوی آسیہ کو فروخت کر دیا ہے جس کے بعد پولیس نے مزید کارروائی نہیں کی اور کہا کہ یہ مقدمہ منڈی بہاؤ الدین میں چلے گا ہے آپ وہاں جائیں اور ساتھ ہی یہ مشورہ دیا کہ

محمد حسین کو ساتھ لے کر گاؤں چلے جائیں اور برہنہ کی مدد سے مسئلہ حل کر لیں۔ ہم محمد حسین اور اس کے والد کے علاوہ دیگر رشتہ داروں کو جرگہ میں لے گئے جہاں محمد حسین نے تحریری طور پر کہا کہ وہ 15 روز میں آسیہ کو واپس لا کر دے گا لیکن اگلے روز ہمیں معلوم ہوا کہ محمد حسین اہل خانہ کے ہمراہ ٹیکسلا سے فرار ہو کر منڈی بہاؤ الدین چلا گیا ہے اور اس نے فون پر لڑکی واپس کرنے سے واضح انکار کر دیا ہے۔ اب منڈی بہاؤ الدین پولیس اسے ٹیکسلا اور ٹیکسلا کی پولیس اسے منڈی بہاؤ الدین کا مقدمہ قرار دے کر نہیں لٹ ہال بنا رہی ہے۔ تاج بروگہ کے مطابق میں ایک نئی کچی کے کچن میں ملازم ہوں۔ جمع پونجی خرچ ہو چکی ہے لیکن میں کا کوئی پتہ نہیں چل رہا کچھ لوگ کہتے ہیں کہ وہ مار دی گئی ہے اور کچھ کا کہنا ہے کہ وہ نہیں فروخت ہو چکی ہے اس شخص نے مجھے ہم پائل کر دیا ہے لہذا چیف جسٹس افتخار محمد چوہدری از خود نوٹس لے کر مجھے انصاف فراہم کریں۔
