Sabir Shah appeared and stated that he had already paid Rs.38,000/- rupees to the applicant and his present salary is Rs.3,500/- out of which he pays Rs.1,000/- to the children out of his wedlock with Naseem Bibi. He has contracted second marriage from which he has two children.

As it is a family matter and maintenance has already been fixed by the court according to the sources of the respondent, therefore, no further action is called for. Disposed of.

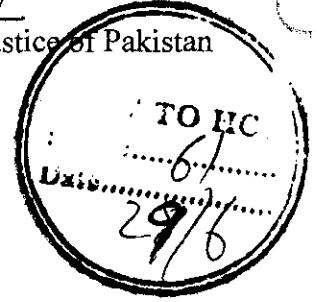

It is requested that I am a poor lady. I have two school going children (1) **Suleman Shah**, son aged 9 years (2) **Syeda Tunnisa**, daughter aged 6 years. At present we are living just like **beggars** in Village Bhekhi Sharif (Dera Sultan Shah) but following cunning by natured and highly influential peoples are extremely teasing us through various means: -

- a. * **Sabir Shah** son of **Mulk Shah** } Village **Kuthiala Syedan**, Tehsil
- b. **Ilyas Shah** son of **Mulk Shah** } & District **Mandi Bahaw Uddin**
- c. @ **Akbar Shah** son of **Sultan Shah** }

It is inform you that I was married to ***Sabir Shah**, but later Mr Shah marry to another lady without my **permission** and **divorced** me without **any reason** on **6-11-2002**. I made many requests for return of my **households worth Rs.10, 0000/-**, but above peoples threatened me that forget the same or else be ready for the serious consequences. The matter was brought to the notice of all Law Enforcing Authorities through petitions, but I am still waiting.

It is further added that The Honourable Mr Justice **Nadeem Abbas Saqi** announced on **22-12-2003** (photocopy attached) that Sabir Shah should pay **Rs.1600/-** per month on account of maintenance allowance for children (Rs.800/-+Rs.800/-), but The Honourable Mr Justice **Muhammad Aslam** announced on **26-4-2004** (photocopy attached) that Sabir Shah would pay only **Rs.1000/-** per month (Rs.500/-+ Rs.500/-), whereas Sabir Shah is a Driver and is taking handsome amount. He also has many other source of income in addition to land properties.

Reduction of Maintenance Allowance by The Honourable Justice is not understood? May I made a request to The Justice that **Rs.500/-** per month is enough for a child to fulfil his normal necessities of life or otherwise? As I have **neither own house nor any source of income** and my households is still held with above peoples.

In these destructive circumstances it is once again requested with **folded hands** that kindly **took pity** upon my innocent children and look into the matter as a special case. Please help me for recovery of my **households**. Also take measures to **increase** maintenance allowance because my innocent children are near to **death due to hunger**.

I will pray for your long life.
