Respected sir,

We the undersigned in habitats of Kandiaro town beg to submit that Mr. Muhammad Sharif Qureshi Senior Judge, Kandiaro, being a responsible officer of judiciary has made clear violation of the orders of the Honourable Supreme Court by arranging meals of different kinds on 06-05-2006 opposite to Civil Hospital Kandiaro wherein he had invited about 5000 to 6000 guests to whom the meals/ dishes of various kinds were openly served to the invitees under the shamianas installed on the spot.

The invitation cards were also got prepared in large number and were distributed among the invitees illegally. The chief host i.e. Mr. Muhammad Sharif Qureshi being himself a responsible Judge of judiciary has made clear violation of orders of Honourable Supreme Court without any justification. This act on the part of officer of judiciary have encouraged the other persons of the locality to indulge in such illegal acts in future.

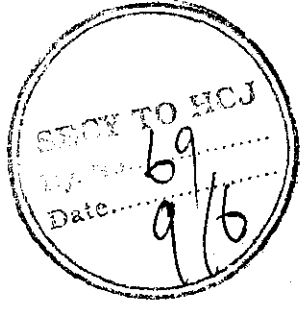
