ORDER

It is informed by Mr. Javed Odho, DPO Hyderabad that earlier this matter was taken up by this Court and disposed of on 16th February 2010 by passing an order in HR Case No. 13401-S/2009. Be that as it may, it has been made clear to him that termination of proceedings, such as cited in case, does not mean that the Court is satisfied and has no concern with the matter, therefore, he has to recover both the missing persons namely Sikandar @ Akash Mallah son of Late Mohammad Siddique and Noor Muhammad Khaskheli son of Mohammad Aachar. The DPO has informed the Court that both the missing persons have not been recovered so far, however, a Joint Investigation Team has been constituted to locate their whereabouts and in the meantime, a case has also been registered in this behalf.

It may be noted that the complainant Mr.Ali Anwar has alleged that the police officials of Bhittai Nagar Police Station handed over the above named missing persons to unknown law enforcing agencies. Therefore, we (47

direct that as the case has been registered and name or the identification of the law enforcing agency has not been disclosed by any body, police should arrest the then SHO of the Bhittai Nagar Police Station and his supervising officer DSP Shabbir Baloch in order to ascertain the whereabouts of the missing persons, named hereinabove. Mr. Fayyaz Ahmed Leghari, RPO, present in Court, is directed to do the needful and submit report by tomorrow i.e. 12th March 2010.

ORDER

A report has been submitted by Police, duly signed by Mr. Fayyaz Ahmed Leghari, RPO Hyderabad, explaining therein that Mr. Ghulam Shabbir Baloch was not the Incharge DSP of the circles on the day of incident i.e. 8th October 2009 and Mr. Sikandar Ali Bhatti was the DSP while Haji Ghulam Mohammad was the SHO. The DPO Hyderabad states that Mr. Sikandar Ali Bhatti, the then DSP is present in Court along with SHO and if some more time is allowed to them, they will make efforts to effect recovery of abductees.

2. It has been made clear to them that the contents of the FIR and the other material available on record, prima facie, show abduction of the citizens in connivance with the Police. Needless to observe that it is primary duty of the law enforcing agency like Police to ensure that such

incident does not take place within their jurisdiction. However, keeping in view the request made by DPO, Hyderabad, we grant 15 days time to him to make further efforts for effecting recovery of the abductees, failing which law shall take its course as the case has already been registered. In the meantime, complainant is also directed to cooperate with the Police and get his statement recorded, substantiating allegation leveled against the Police. After expiry of stipulated period, report shall be submitted to the Registrar of this Court for our perusal in Chambers without fail. However, if the Police succeeds in effecting recovery of abductees, they shall be produced before the Sessions Judge, Hyderabad for recording their statements accordingly.



I request for immediate release of my brother <u>Sikandar alias</u> Aakash and his Fried <u>Noor Mohammad Khaskheli</u> from the illegal detention from Police/Un known Law enforcing agencies.
